An application form is attached – if you would like to apply for Free School Meals please return this with your proof of entitlement (i.e. the document you received from the relevant agency showing your entitlement).

Should you be entitled to the free school meals scheme you should be aware that you have a legal duty to inform your school of any changes to your support payment. Reapplication to the scheme will be required on a six monthly basis.

About this form

From September 2014 all children who are in reception, year 1 or year 2 in a state-funded school have been offered a free healthy school lunch. Children in other school years will also be offered a free school lunch if their parent is receiving any of the welfare benefits listed. Registering for free meals could raise extra money for your child's school to fund valuable support.

How the information in this form will be used:

The information you provide in this form will be used by the council to confirm receipt of one of the listed welfare benefits. Once this is confirmed, this helps to decide how much money your child's school will receive each year.

For children in year 3 or above, the information will also be used decide whether they are eligible for free school meals.

Thank you for completing this form and helping to make sure your child's school is as well funded as possible.

We are committed to ensuring that the personal and sensitive information that we hold about you is protected and kept safe and secure, and we have measures in place to prevent the loss, misuse or alteration of your personal information.
